"Court Watch Montgomery: How This Volunteer Program
Protects Women and Children"
Speaker: Laurie Duker,

Executive Director and Co-Founder of Court Watch Montgomery

The May 17 Branch meeting at the Gaithersburg Library at 7 p.m. will first present, as speaker, Laurie Duker, executive director of Court Watch Montgomery. This is a nonprofit organization whose volunteers monitor restraining order court hearings and other proceedings to ensure that domestic violence victims are being treated properly and with respect by the county court system. Their principal goal is to "reduce domestic violence in our county and the state, as well as to improve the safety of domestic violence victims and their children by monitoring domestic violence cases and identifying problem areas and providing and promising strategies for improvement." Ms. Duker will discuss the current status of court reforms in this area as well as the group's efforts to get guns out of the hands of abusers.

After the speaker's presentation, we will have our annual business meeting during which the newly elected officers will be officially installed for the 2016-17 term. You will find the list of officers and brief biographies further in this newsletter.

MEET THE OFFICERS FOR 2016-17

At the April 19 Branch meeting the following officers were elected for the 2016-17 term.

President

Heather Reichardt has been president of AAUW Gaithersburg for the past year. She serves also on the Montgomery County Commission for Women, as well as working with the AAUW Lobby Corps and taking a lively interest in activities related to her profession. After 25 years with Marriott International as director of lodging and property tax, she is now director for property tax, hospitality, state and local tax and advisory for the Altus Group U.S. Inc. where she covers property tax management and analysis of real estate tax assessment values. She has a bachelor's degree in business administration concentrating on real estate and economics from American University, and she has a master's in institutional real estate from Johns Hopkins University.

Co-Vice President for Program

Carolyn Fisher has been the co-vice president for program for the past year. She also serves as the STEM chair and is a member of AAUW's Lobby Corps. She has 16 years of experience in scientific research and writing, having written meeting summaries for several institutes of the National Institutes of Health, as well as progress reports and funding proposals. She also has edited scientific manuscripts and coordinated and performed biological research. Carolyn is interested in informal STEM education and outreach. She is currently a STEM specialist-in-the-classroom volunteer for Montgomery and Prince George's counties and routinely serves as a science-fair judge in the public school system. Carolyn periodically reviews fellowship applications for Graduate Women in Science and serves as an abstract reviewer for scientific and professional organizations that she supports. She has a doctoral degree from the University of Iowa.

Co-Vice President for Program

Marilyn O'Connell is finishing four years as co-vice president for membership, seeing in a growth in membership. She graduated from the University of Maryland with a bachelor of science degree in business administration. She worked in the personnel department of American Airlines for several years. She was active in the Auxiliary of Good Samaritan Hospital in Babylon, Long Island, organizing fundraising events. When her children were school-age, she worked at Diamond Elementary School in Gaithersburg as a math aide, testing children in the ISM Program, then later oversaw the math program.

Vice President for Membership

Barbara Garrard joined AAUW about a year ago after attending a lecture and learning about the book sale

and our scholarships for women. She then became involved in sorting books and she worked at the 2015 book sale. She earned a bachelor of arts degree in mathematics from Fairleigh Dickinson University. She was employed as a federal contractor before working for 25 years for the Montgomery County government managing the data center, network and data security teams. She is a past president and current board member of the Montgomery County Retired Employees' Association and past board member and database administrator for a Washington area genealogy society.

Treasurer

Terry Medlar has been the Branch treasurer for the past three years following her stepping in as acting treasurer in mid-term when the then treasurer resigned. Before that, she was co-president for a year, and she was also a member of the AAUW Lobby Corps. During her term as treasurer, she has done a great deal of work updating the treasurer's records. Terry is a retired software engineer and has a bachelor of arts degree in mathematics from the College of Mount Saint Vincent.

Recording Secretary


Marybeth Morsink has been recording secretary for this past year. She joined AAUW out of respect and conviction for AAUW principles and advocacy for women's rights. Born in Japan of missionary parents, she grew up on Long Island, New York. She earned a bachelor of arts degree from Wheaton College in Illinois, a master of religious education degree from what is now the New York Theological Seminary, and a master's degree in social work from New York University. She was a professor of social work at the Beirut College for Women in Lebanon, followed by employment by UNICEF in community development, also in Lebanon. Later, in Switzerland, she was a consultant at the United Nations High Commission for Refugees, establishing counseling services in major capitals in Africa. After retirement, she represented Consumers International at the United Nations in Geneva, promoting legislation guaranteeing women's rights.

Corresponding Secretary

Jane Carroll has served as corresponding secretary for the past three years. Prior to that, and almost immediately after joining the Gaithersburg Branch, she became active with book sorting and collecting books for the book sale. She is a graduate of Smith College, where she earned a bachelor of arts degree in sociology, and she is also a graduate of Boston University's graduate program in deaf education. AAUW PUBLIC POLICY, MARYLAND LEGISLATIVE AGENDA FOR WOMEN, AND THE MARYLAND LEGISLATURE

AAUW has been pushing hard for equal pay for equal work. In Maryland, AAUW has worked with the Maryland Legislative Agenda for Women to push this, as well as other, legislation. The Maryland Legislature has come to an end for the season, leaving us with some successes and some failures. The Equal Pay for Equal Work bill did pass. In 2016 women make an average of 78 cents on the dollar for doing the same work as men. Senate Bill 481, which passed, puts sunlight on this. Employees cannot now be penalized for discussing salaries, thus revealing pay disparities and allowing women to demand their fair share.

The Maryland Healthy Working Families bill did not pass. This bill would have mandated that employers with at least 15 workers provide paid sick leave. The bill will be reintroduced next session. The Rape Survivors Protection Act would have allowed the mother of a child conceived by rape to petition the court to disallow the father from having a say in anything to do with the child, such as parental visits. This failed at the last minute. It, too, will be reintroduced next session.
