TEMPORARY PRESIDING OFFICER'S MESSAGE

As you know, we canceled the January 11 branch meeting. Our program vice president didn't have enough time to find a replacement when our planned speaker could not attend.

I believe our February 15 speaker, Tazeen Ahmad, will make up for the January disappointment. She is a member of the Montgomery County Commission for Women and the chair of the Women's Legislative Briefing, as well as starting a nonprofit benefiting children in our area.

AAUW national continues to focus on ongoing public policy activities in support of women and girls. This is so even as budget constraints have forced cuts in staff and reduction of activities such as Lobby Corps. Here are some highlights.

- Lobby Corps continues monthly or bimonthly, rather than weekly, Hill visits. On January 30 AAUW members lobbied the Senate to advocate for the Paycheck Fairness Act, specifically targeting all senators who are not current cosponsors (all Republicans). AAUW professional staff provided facts, talking points and letters from AAUW and our coalition members to the senators. Members of the Gaithersburg Branch are active in Lobby Corps. We invite other members to join us.
- AAUW achieved its goal of training more than 102,000 women in salary negotiation skills in 2019 through our Work Smart and Start Smart programs. This accomplishment was stimulated by a \$500,000 grant from The Coca-Cola Foundation, the largest corporate gift in AAUW history. The grant also

supported Empower, AAUW's new leadership development and networking event hosted in Atlanta, Chicago, Charlotte, Boston, San Francisco and Washington, D.C., in 2019. Additional leadership development efforts are planned for 2020.

- For the 2019-20 academic year, AAUW has awarded more than \$4.3 million in fellowships and grants to 270 recipients to advance educational and professional opportunities for women around the globe. AAUW members have been so generous over the years that the organization now has sufficient funds to support fellows and grantees for the next 50 years!
- AAUW president Kim Churches hosted a webinar on January 28 to explain the organization's 2020 plans. The webinar will be available in the AAUW website after the live event. A second webinar is scheduled for April 14.

Last but not least, our branch needs volunteers to assist in planning and coordinating branch meetings and other activities . Please contact any officer listed in this newsletter. We have opportunities that can be structured to fit your schedule and interest.

PATHWAY TO RATIFICATION - FEBRUARY 1920

Continuing our series on the ratification of the 19th Amendment, we find the sun shining on the pathway to ratification one hundred years ago this month. If you were reading the Washington Post back then, you might have seen an article such as the following.

The sweep in December and January that saw states ratifying the 19th Amendment continued this month with ratification by Nevada, New Jersey, Idaho, Arizona, New Mexico and Oklahoma.

Idaho and Arizona had previously given women the vote, so ratification there was straightforward and without incident. Alice Paul and her followers in the National Women's Party organized an enthusiastic vote among women for ratification there.

Carrie Chapman Catt and her National American Woman Suffrage Association campaigned in Oklahoma, as they did in other states back in 1918. It was then that the influenza epidemic hit and interfered with campaigning. Meetings larger than 12 were not permitted, so much of the campaign was promulgated through the newspapers. Voter fraud was rampant; suffra-

gists took watch over the polls, guarding the counts. Ms. Aloysius Larch-Miller, seriously ill with the flu, insisted upon speaking at a ratification rally despite doctor's orders. She died two days later. Such was her rousing call to action that when Oklahoma now ratified the 19th Amendment these two years later, they ratified it as her memorial.

Meanwhile, back in our area, both Maryland and Virginia voted against ratification. Maryland, so aroused, passed a resolution rebuking the federal government for having passed the Amendment in the first place. Now, Maryland has sent delegates to other states to convince them to vote against ratification. Though only three more states are now needed toward the 36 needed for ratification, such incursions as Maryland's, particularly into the obdurate southern states, will make the pathway to ratification more unpredictable.
