### PRESIDENTS MESSAGE

Fall is here! My neighbors have four large pumpkins on their front patio already. I guess I am behind the curve on fall/Halloween decorating even though it's still September as I am writing. We have less than two months to go until the November 5 election day. It seems that most of the media space is focused on the presidential election. But, there are important state and local elections that may directly impact women's and children's lives. One of those is Question 1, which will be on the Maryland ballot. We heard about this ballot initiative from Julie Rancel of Montgomery County NOW at our September branch Zoom meeting. Thank you to the members who attended that important meeting. While abortion is currently legal in Maryland, many want to enshrine the right in the state Constitution so that it would be difficult for legislators to remove the right. If Question 1 is approved, Maryland will be a safe place for in-state and out -of-state people who seek abortion care. As it stands now, the law could be repealed if enough legislators wanted to do so.

I mentioned in the Zoom meeting that I had attended a reproductive justice rally at the County Council building in Rockville on September 10th. On that day, led by Council Member Kate Stewart, the Council approved a resolution affirming their support for legal abortion and reproductive health care as a human right in Montgomery County. The rally was supported by a coalition working to get as many counties and cities in Maryland to pass similar resolutions and/or ordinances. Advance Maryland and Reproductive Justice Maryland are two of the coalition members. You will recall that we had Sharon Burgis of Reproductive Justice Maryland speak last year at one of our Zoom meetings.

Another group in the coalition is Ipas (www.ipas.org). This group has been promoting and fighting for access to abortion internationally since 1973. However, since the Dobbs decision in 2022, they have turned their attention to the United States reproductive health care issue. They rely on three international, human rights-related treaties, which the US has ratified. Per an Ipas summary document, the United Nations has expressed concern over the limiting of abortion access and encourages the US government, at all levels, to take swift action to bring the US in line

with its obligations under the IC-CPR (International Covenant on Civil and Political Rights). This is a new strategy to get the country to conform to the human rights treaties it has signed on to.



The day after our Zoom meeting, Julie sent me this graphic which answers the question about shield laws that protect those entering clinics from the Center for Reproductive Rights (reproductive rights.org).

# In Maryland: Land Acknowledgement (by Montgomery College, Office of Equity and Inclusion)

Mr. Rico Newman, a member and Elder of the Piscataway Nation, in 2023 helped recognize Montgomery College acknowledgement of the indigenous residents of the land where the Montgomery College campuses are located, "For non-indigenous communities, land acknowledgment is a powerful way of showing respect and honoring the Indigenous Peoples of the land on which we work and live. Acknowledgment is a simple way of resisting the erasure of Indigenous histories and working towards honoring and inviting the truth. Creating land acknowledgments is an institutional responsibility. Incorporating them in official higher education communications and work creates greater visibility of Native American students and communities, while acknowledging tribal sovereignty and honoring those that came before. Such actions also demonstrate our commitment to diversity, equity, and inclusion."

Mina, a Holocaust survivor, had her first interaction with AAUW in 1954 when she received an AAUW scholarship to attend the University of California at Berkeley. She juggled participation in branch meetings with raising a family and teaching French for many years. Mina now lives at Ingleside King Farm and often participates in branch virtual meetings.
